## I. BACKGROUND



The NOI is an all-black nationwide organization headquartered at Muhammad's Temple (MT) 2, 7351 South Stony Island Avenue, Chicago, Illinois, under the guidance of ELIJAH MUHAMMAD, self-styled "Messenger of Allah" and alleged divinely appointed leader of the black race in the United States. Its purpose is separation of the black man from the "devil" (white race) through establishment of a black nation. Followers are instructed to obey the laws of the land if they do not conflict with NOI laws and not to carry weapons, but are to defend NOI officials, their property, women, and themselves if attacked at all costs and are to take weapons away from their attackers and use same on the attacker.



## C. Health

"The New York Times," daily edition of December 6, 1973, Section C, page 37, sets forth an article entitled, "Black Muslim Group in Trouble From Financial Problems and Some Crime." It reflects:

## II. CONNECTION - NOI

### A. Teachings

The Annual Muslim Convention (AMC) was broadcast live over Chicago radio station WVON, 1450 AM, from 2:00 p.m. to 3:30 p.m., February 26, 1974.

ELIJAH MUHAMMAD was introduced as the last Messenger of God. He spoke as follows:

much that can be interchanged between the white man and the black m.n. God gave way for the white man to rule. Honor and respect them while they rule. 'This I mean from my heart." Everywhere you go respect people and people will respect you. Do not think you are so great now just because God promised you the Kingdom. until you get in it. God does not raise us up to mock and disrespect. Show the world we are a righteous people trying to set up the characteristic in our people of righteousness. we do not want our people acting unrighteous. The devil was made by the black man. There is a lot you must learn to do to show the world who we are. we are not raised up to mock people. we are raised up to show the world what righteousness looks like.

Today you are on your way to becoming the only ruler of the Earth. If you come into Islam, you will become a beautiful nation. You wanted to be free to do something for yourself. That is all you wanted. Go help yourself.

Go to war with no man for that of his own.
Do not fight nobody over what is theirs. Just get
yours and keep yours and let him keep his. If God gave
it to him, that is his and God's. Take that what God
has given you and make something out of it. Allah has
loosed us. All we have to do is go to work. Stop
looking at other people's profits, looking for them to
give you things. You do not take nothing. If they are
taking it from the Indians, let the Indians take for
their own. The Indians let the white man, a stranger,
take over their land. well, we are strangers too.

we can call our own. Over 30,000,000 of us are running from one state to another like wild animals. we must find a home. I can not wear a crown with no country. If God comes to bless us, he must bless us with giving up some of the Earth that we can call our own.

begging the white man to give them something. what better gift could he give you than freedom to get for self? Be straight, fair and kind. The white people did not treat us as they should have. If they had, they would have given us freedom, justice, and equality and that is not his nature to do. Blame yourself for putting that nature in the white man. The fault is not on the slavemaster any more since the said you can go free and we see that he is not angry with us. We are hindering ourselves. Give justice to him when it is due. He can not hold you as a slave. You are holding yourselves as slaves.

The AMC was held by the NOI and by MT 2, Chicago, on February 26, 1974, at General Richard L. Jones National Guard Armory, 5200 South Cottage Grove Avenue, Chicago. Attendance approximated 18,000 - 20,000, same comprised of about 75% followers of ELIJAH MUHAMMAD.



"Muhammad Speaks" (MS), March 8, 1974, pages twelve and thirteen, sets forth what is described as excerpts from Messenger MUHAMMAD's 1974 Savior's Day address. The following was noted:

represent God, as you and me know—they'd be giving away the power to rule.

They were not to rule under the teachings of reality of God; they were made to hide the reality of God in order that they themselves can be worshipped. I don't get angry with them the way that they rule and what they teach.

## DETAILS:

I. Background



The Nation of Islam (NOI) is an all-black nationwide organization headquartered at Muhammad's Temple 2, 7351 South Stony Island Avenue, Chicago, Illinois, under the guidance of ELIJAN MUHAMMAD, self-styled "Messenger of Allah" and allegedly divinely appointed leader of the black race in the United States. Its purpose is separation of the black man from the "devil" (white race) through establishment of a black nation. Followers are instructed to obey the laws of the land if they do not conflict with NOI laws and not to carry weapons but are to defend NOI officials, their property, women and themselves if attacked at all costs and are to take weapons away from their attackers and use same on the attacker.



"According to the newspapers, America used to dump wholeboat loads of sugar into the ocean, in order to raise the price of sugar.

"And you know for yourself, that they set whole fields of cotton afire. And to keep the people from planting full fields of cotton, they made the farmers plant cotton in every-other-row, and if they, (the farmers) planted more than that, they made them plot the rows under.

"America was so fully blessed by God that America destroyed her own blessings. America may seed her blessings now - and soon, for people are getting hungry, and the Bible prophesies that the people ate one another before the famine was over.

"We cannot blame anybody but ourselves when famine comes upon us. And, I think the people over there stare at us with a dark eye - a dark eye because they can see - Woe To America - that had once so plentiful in food. America is now becoming blackened with the dearth in her midst."







AT CHICAGO, ILLINOIS. Will follow the activities of POOLE, who is more commonly known as ELIJAH MUHAMMAD, and will report pertinent developments in form suitable for dissemination.

#### ADMINISTRATIVE:

Attached are two copies of an FD-376.

A copy of this report is being furnished to U. S. Secret Service, Chicago, Illinois, in accordance with the agreement between the FBI and that agency relating to protection of the President of the United States and other governmental officials.

A copy of this report is being furnished to Phoenix for information as MUHAMMAD maintains a residence in that city. It should be noted that he rarely utilizes same.

An extra copy of this report is being furnished to the Bureau for possible transmission to Legat Mexico City as MUHAMMAD apparently has a residence in Cuernavaca, Morelos, Mexico. Information in this report indicates MUHAMMAD desires to visit Mexico again and also indicates the mode of transportation he may use for such a trip which may be of assistance to Legat, Mexico City.

#### Interview

As is noted in this report, KLIJAH MUHAMMAD was interviewed by Special Agents (SAs) and consider the following factors:

1) The fact MUHAMMAD is a prominent black leader in the Chicago area and in the past year was given a day by the State of Illinois and by the City of Chicago and the Governor of Illinois and the Mayor of Chicago, paid more than simple respects to him;

- 2) MUHAMWAD recently was in the hospital and is still recuperating from that illness;
- 3) MUHAMMAD is 77 years old and has been described to the Agents by confidential informants as being in good health despite his age but as continuing to recuperate from his illness, but as feeble, and at times is contankerous as befits a man of his age and a man in his position;
  - 4) The Agents were guests in his home and were hoping to avoid any incident which could cause MUHAMMAD to become cantabkerous or could cause him to become ill, which certainly would destroy any hopes for communication between him and the FBI;
- 5) MUHAMMAD lives in a closed society being totally surrounded by "Yes" men. He is not used to being interrupted nor would he have responded to direct questions. By bearing the above factors in mind, it was the hope of the Agents that communication would eventually be achieved, that MUHAMMAD become more aware of the aims and purposes of the Bureau and that he would eventually be willing to assist the Bureau in achieving these aims and purposes.

MUHAMMAD was non-committal in that he would not make a direct statement that he would assist the FBI. He did indicate he would help as time permitted him to do so. It is the opinion of the contacting Agents that the interview was successful to a large degree but that further contacts on an extremely limited basis will have to be made to bring this contact to a successful conclusion as far as communication and trust is concerned. It is not felt MUHAMMAD can be, or should be, contacted too frequently.

on 11/12/74. He commented he believed in law and order and obeying the laws of land in which he lives and stated he loved America very much. He stated that if they could not obey the laws of this land, they should leave. He indicated he was in favor of helping enforce the laws of the land and that he felt same should be done. He stated we must live in peace and the killings must be stopped and the white man and the black man must learn to live together and to respect each other if America is to survive. He added Agents could come back to his house "anytime they wanted". MUHAMMAD has Lockheed Jet Star, Registration #N1924V at disposal for travel and indicates he desires to visit Mexico. Recognition of MUHAMMAD for his works by various "leaders" set forth.





and attempted to fulfill a prearranged weeting with ELIJAH MUHAMMAD at 4855 South Woodlawn Avenue, Chicago. VELORA NAJIER, self described as MUHAMMAD was ill and confined to bed, but that MUHAMMAD had given the authority to talk to the Agents. SULTAN MUHAMMAD, self described as ELIJAH MUHAMMAD's grandson, sat in on the interview at the request of the Agents.

NAJIEB was advised the Agents desired to pass on to MUHAMMAD the details of an Obstruction of Justice matter (see below) involving a threat on one EHNEST KELLY, his wife and family, by "Muslims" and also details of general activities of "Muslims" in Philadelphia, Pennsylvania as relates to Armed Robberies, Bank Robberies, Extortion, Drug Activities, etc., in the Philadelphia area as it appeared such activities were not sanctioned by MUHAMMAD and were damaging his reputation. NAJIEB was givenfull and pertinent details regarding the above.

NAJIEB was emphatically advised the FBI was not interested in the religious teachings or economic endeavors of the NOI; that the interest lies in individuals claiming to be NOI members or actual NOI members involved in criminal activities and using the NOI as a shield for their criminal activities.


It was emphasized the only purpose was to let MUHAMMAD personally know of illegal activities in the Philadelphia area by "Muslims" which could be embarassing to him.

NAJIEB was advised the Agents would like to meet with MUHAMMAD when he was feeling better and that if he had further questions all that needed to be done was to contact the Agents. She assured the Agents she would pass the information on to MUHAMMAD.

On leaving, the Agents met RAYMOND SHARRIEFF To who appeared to be listening to the interview on an intercom system. NAJIEB also took the interview down in shorthand. The possibility existed the interview was taped...

SULTAN NUHAMMAD accompanied the Agents to their car and assured them he understood what the Agents were trying to accomplish and added he personally would relate what the Agents said to his grandfather.

The matter referred to above involving ERNEST KELLY is "JOHN WILLIE CLARK, AKA. ET AL; CONTINENTAL BANK, BROADWAY AND NEDRO STREETS, PHILADELPHIA, PENNSYLVANIA, 2/8/73; BR, CONSPIRACY, CARRYING FIREARMS IN COMMISSION OF FELONY; OOJ".

On November 12, 1974, SA telephonically contacted the residence of ELIJAH MUHAMMAD and ultimately was connected with VELORA NAJIEB. Miss NAJIEB was asked how Mr. MUHAMMAD was feeling and also advised the Agents desired to discuss the interview of two female members of the organization in connection with a Fraud By Wire matter. Miss NAJIEB advised that MUHAMMAD had told her that if Agent called again he was to be advised he, MUHAMMAD, would be most happy to meet with him. Miss NAJIEB was told that such a meeting would be at the discretion of MUHAMMAD. She asked Agent to hold for a moment and she returned to the phone stating MUHAMMAD would meet with Agent between six and seven o'clock that evening.

At approximately 5:50 PM, SAs and arrived at MUHAMMAD's residence and were greeted at the gate by a guard who asked for their identities. The Agents identified themselves to the guard and he proceeded to the front door. In a few moments he returned and opened the gates and took the Agents to the door where they were greeted by RAYMOND SHARRIEFF and SULTAN MUHAMMAD, and others. The Agents were escorted to a waiting room where they were assisted in removing their costs and were treated in a cordial manner. In a few

moments, KLIJAH MUHAMMAD was observed approaching the room, obviously having just left the dining room table. At this point, the Agents were asked if they had weapons and as MUHAMMAD approached the room, the Agents were briefly searched around the chest-area.

MUHAMMAD, upon entering the room, was joking and smiling and referred to the Agents meeting with NAJIEB on October 20, 1974, stating she had commented the Agents were the biggest devils she had ever seen. He also asked the Agents some joking question about them being Christians, and he was advised the Agents were, but were not qualified to say whether they were good, bad or indifferent Christians. MUHAMMAD laughed at this remark.

MUHAMMAD had difficulty seating himself and appeared feeble. He asked the Agents what they wanted to discuss and was told the Agents were sure that he had been briefed by his efficient secretary about the threats on the life of ERNEST KELLY, his wife and family, in an Obstruction of Justice matter coming to trial in Philadelphia; that these threats appeared to have been made by members of his Temple in Philadelphia. MUHAMMAD was briefly advised that it was the opinion of the Agents that some of his followers were hiding behind his teachings and were committing crimes such as murder, bank robberies, extortion, among other things, and were also possibly involved in drug activities in the Philadelphia area. MUHAMMAD indicated he was aware of what was said during the discussion between the Agents and NAJIEB and slowly, and almost inaudibly, began talking in theological manners about his teachings.

He talked for several minutes and finally was interrupted by the Agents and told they could not hear him because of piped-in music in the room. MUHAMMAD ordered SULTAN to turn the music off and reprimanded SHARRIEFF for not sitting or standing at his left side during the meeting. The music was turned off, and even then, MUHAMMAD's statements were all but inaudible, for the most part, to the Agents. As far as could be determined, in essence, he spoke about how grieved he was to know, and he indicated he did, that some of his followers were involved in criminal activities. He stated there are the civilized and the uncivilized and he tries as best he can to teach the uncivilized to be civilized.

He commented that they have their own methods of handling individuals who break the law if they find that out and he added these methods could be quite drastic in certain cases, but that he realized that they would be breaking the law if they went too far in this punishment. He indicated that the punishment he was referring to was suspension from the Temple and from association with the Temple body and commented this hurts his followers more deeply than the Agents could realize.

He commented he believed in law and order and obeying the laws of the land in which he lives and stated that he loved America very much. He stated that if they could not obey the laws of this land, they should leave. He stated that if it came to the attention of the FBI that he or his group were breaking the law, he would want to know about it so he could rectify this matter.

MUHAMMAD stated he had always wanted to be a judge, adding that he felt he could deal with criminals and reform them very well, but he did not expect to ever be appointed to be a judge. He stated that he realized there were the uncivilized in his group but it was impossible for him to know what each and every member of his group was doing, adding he was busy every day until midnight and did not possibly have time for this.

The above portion of the interview was practically one hundred percent talking by MUHAMMAD. He talked extremely slow, and paused at times for several moments as if he were reminiscing or possibly trying to gather his thoughts for further comments.

At this point, he asked the Agents if they had any questions or problems with which he could help them with. MUHAMMAD was told the Agents, and they hoped he understood, were not meeting with him in connection with his religious teachings or in connection with his economic endeavors; that their sole purpose was to let justice run its course and in the matter involving ERNEST KELLY, to let KELLY testify without duress or without threats from what appeared to be members of MUHAMMAD's group. It was pointed out to MUHAMMAD that the FBI



-was purely and simply a fact-finding agency and was charged with the investigation of over 300 different laws of the United States; that the FBI in investigating these cases gathered facts, both mitigating and aggravating and that these facts were turned over to the United States Attorney who decided whether the matter would be submitted to the Grand Jury for further trial. He was advised the FBI tried to deal in every matter in a fair and concise manner. MUHAMMAD was further advised that the FBI has had many allegations involving the Black Muslims and that FBI investigation was conducted in many or these matters to determine if, in fact, the allegations were true or untrue and that in many cases, the FBI had been able to absolve his group from involvements in the allegations. WUHAMNAD was also advised that the FBI gets many fugitive-type cases involving alleged Black Muslims and that the FBI would like to have communication or rapport with a responsible official of the NOI at MUHAMMAD's Temple 2, and, if possible, at every Temple so FBI Agents would not be constantly knocking on the doors for information, basing this out of respect for his religious organization.

MUHAMMAD appeared quite thoughtful-at this statement and unit imately spoke about contacts he had had with other Agents. He stated something to the effect he could not be a stool-pigeon, but, on the other hand, he indicated strongly that he was in favor of helping enforce the laws of the land and that he felt same should be done.

At this point, MUHAMMAD again went into short dissertation in a theological manner about the laws of Islam and the laws of the United States and how they should be obeyed.

He stated that he kad much food and much refreshments and he wished the Agents would partake of the refreshments. The Agents politely refused and MUHAMMAD again went into a short theological type discussion about his teachings and stated that we must live in peace and the killings must be stopped and the white man and the black man must learn to live together and to respect each other if America is to survive. He appeared quite emphatic in this statement and again stated how much he loved America.

Again, he offered the Agents refreshments and was told the Agents would appreciate a glass of water. He immediately dispatched SULTAN for the water and began reminiscing about working as a laborer on a railread in the deep south and commented he was born in Georgia and was 80 years old.

He seemingly relaxed and stated that his followers had bought him this house and the Agents commented how beautiful it was. He stated it should be, as the Agents' people (apparently referring to the white race) built it and had done a wonderful job. He then stated that his followers had bought him an airplane and that his grandson, SULTAN, could fly it but he had never even seen the plane, yet his sons had been all over the world with it. He stated he desired to fly to Mexico, but was actually afraid to fly, referring to having his feet on the good, hard ground. The conversation then lapsed into a general mood of levity, discussing MUHAMMAD's fears of flying and yet desiring to travel.

At this point, HERBERT MUHANNAD, who was so identified by ELIJAH MUHANNAD, entered the room and embraces between father and son occurred. MUHANNAD told HERBERT the Agents had come to arrest him and he was sending HERBERT in his place. MUHANNAD had a big laugh out of this and HERBERT said he was not going.

concerned about the length of time MUHAMMAD had been talking and were desirious that the Agents take leave, although they did not request the Agents to do same. The Agents turned to MUHAMMAD and he stated, "You can call me at any time regarding any problem and you can call me or SHARRIEFF". At this point, he shook hands warmly with both the Agents and told those present to observe these Agents stating they had gone to school and learned their lesson well and were the "finest". Agents he had ever met", and they could come back to his house "any time they wanted". Again he stated that he was a very busy man, but that he would, if the Agents called, eventually return their call.

At this point, the Agents departed and were accompanied from the house by RAYMOND SHARRIEFF and HERBERT MUHAMMAD, who were happy and smiling, to their car. The Agents apologised for taking so much of MUHAMMAD's time and hoped they had not over-tired him because of his recent liness: Beth assured the Agents all was well. RAYMOND SHARRIEFF was waked if it would be all right for the Agents to call him and he replied that "the man" said to call him, MUHAMMAD. It should be noted that neither SHARRIEFF, SULTAN, or HERBERT made any comments during this interview other than to say "yes, sir" or "that's right" after MUHAMMAD had made a statement.

The interview lasted from approximately 6:00 PM to 7:45 PM. It should be noted, as pointed out above, that MUHAMMAD spoke in an almost inaudible voice and much of the time it was very difficult to understand him.

Contacted NAJIEB and was immediately put in touch with her. Agent was asked NAJIEB if MUHAMMAD was in good health, commenting the Agents were concerned because of the excessive time MUHAMMAD had given them: She seemed quite cordial and assured the Agents MUHAMMAD seemed to be in exceptionally fine spirits.

## IV. Teachings

"Muhammad Speaks" (MS), September 20, 1974, carried headlines as follows:

"PAY YOUR DEBTS!

Dear Brothers and Sisters:

"There are many white people writing me now saying that you do not pay your debts. You know I have not taught you any such wicked idea.

"I am going to put out of the Temple (those who are doing this) for example for those to come in the future.

"You are spoiling our credit and I am going to put you out of the Temple and let white folks know that I am not on your side in not paying them the bonest debts that you owe to them because I know Allah Blesses you to have the money to pay your debts as long as you are not extravagant.

Elijah Muhammad, Messenser of Allah"

## VI. Travel-Airplane



MS, August 16, 1974, sets forth headlines "A Jet for Muhammad". Page 5 reflects as follows:

"The Muslim followers of the Honorable ELIJAH MUHAMMAD...have pledged themselves to raise more than \$1 million within the next 90 days in order to pay the complete cost of purchasing a Lockheed Jet Star Executive jet aircraft for the use of Mr. MUHAMMAD, the last and greatest Messenger of Almight God Allah.

"The aircraft...has four Pratt-Whitney engines for maximum safety, while cruising at speeds up to 570 miles per hour. The fully pressurized and air conditioned jet will carry 10 passengers and crew in all the speed and comfort of the most modern 707 and 727 commercial jet airlinrs.

"The Muslim jet, which has a full-sized galley for comfort, and double and triple back-up Avionics systems for safety, is equipped with air to ground telephone, and is the same aircraft used in the United States Presidential fleet..."

The files of the Aircraft Registration
Division, Federal Aviation Administration, Oklahoma
City, Oklahoma, reflect Registration Number N1924V is
assigned to Lockheed Model 1329 (jet star), Serial
number 5077. On September 13, 1974, the ownership
of this vehicle was changed from the First National
Bank of Chicago to SULTAN MUHAMMAD, 4855 South Woodlawn
Avenue, Chicago on September 26, 1974, an Attorney
from Chicago asked the registration on the Lockheed
Jet Star, Model 1329, Serial number 5077, he changed
to NOI-EM. This request was denied but the aircraft
was given the new registration number of NI-EM conditionally pending receipt of \$10.00 fee. This aircraft was not able to be registered under the registration

## VII. Public Relations

### A. Recognition

MS, September 20, 1974, on Page 5, sets forth an article titled, "Black psychologists honor Muhammad's work: For 43 years of dedication" date line Nashville, Tennessee. The article reflects that the National Association of Black Psychologists in the mid 1970s, had honored ELIJAH WUHAMMAD "for contributions to the economic, social, and spiritual development of the black community". The award was accepted by Minister LOUIS FARRAKHAN, National spokesman for the NOI.

MS, October 4, 1974, Page 4, sets forth an article entitled, "N.Y. Governor proclaims 'Black Family Day'-Messenger Muhammad's brothers head long dignitary list" date line New York.

The article reflects Governor MALCOLM WILSON proclaimed last September 15 as "Black Family Day" throughout the entire Empire State marking an official tribute to the influence of the Honorable ELIJAH MUHAMMAD's teachings on the East Coast and across North America; that honored guests included Ministers JOHN MUHAMMAD and JOHNNY MUHAMMAD, brothers of ELIJAH MUHAMMAD.

MS, October 11, 1974, on Page 4, sets forth an article entitled "Ark. Black leaders vow to assist Muhammad-Black political convention leader declares, 'Muhammad has the answer!'", dateline Little Rock.

The article reflects that because ELIJAH MUHAMMAD "has the plan" and it is being "successfully implemented", the state convener of the Arkansas Black Political Caucus and several other Arkansas black "leaders" have vowed to financally and otherwise assist in establishing a Muhammad University of Islam in Little Rock (Arkansas); that EVERETT SHELTON, State Convener of the Arkansas Caucus stated, among other things, that he has decided to "join the Nation with my family because it is the only way. The Messenger has the answer".

MS, November 1, 1974, on Page 20, sets forth an article entitled, "Black police official sees menacing trend in society's 'lack of respect for others', dateline Chicago.

The article reflects that MITCHELL WARE, a Deputy Superintendent of the Chicago Police Department, and third Highest ranking officer in the department, was interviewed and among other things, spoke highly of ELIJAH MUHAMMAD and his followers as a crime-fixee segment of the black community; that he stated "That's one of the reasons I've always respected Mr. Muhammad even before new that they've gained a measure of respectability... You have to admire the man for the way those people conducted themselves".

MS, November 8, 1974, on Page 6, sets forth an article entitled, "Haitian official finds Muhammad's work, 'fantastic!'-Muslim tour awas diplomat", date line, Chicago.

The article reflects SERGE ADAM, Consul General of Haiti for Chicago and the Mid West, had recently toured NOI enterprises in Chicago and stated, "When you look at the work of the Honorable Elijah Muhammad, its fantastic!"




## NATION OF ISLAM

The Nation of Islam (NOI) is a black nationwide organization headquartered at Muhammad's Temple #2, 7351 South Stony Island Avenue, Chicago, Illinois, under the guidance of Elijah Muhammad, self-styled "Messenger of Allah," and alleged divinely appointed leader of the black race in America. The NOI seeks a separate black nation, considers all whites to be "devils," and preaches a distorted version of the traditional Islamic religion. NOI internal dissidence and difficulties with rival Muslim groups, and other adversaries, have produced considerable violence in recent years. NOI official policy instructs members to obey United States laws that do not conflict with NOI laws; to defend NOI officials, property, women, and themselves at all costs, if attacked; and to disarm any attacker and use the attacker's weapon against him. Male NOI members regularly receive judo and karate training. NOI activity is widespread among black inmates in many prisons in the United States.

## FRUIT OF ISLAM

The Fruit of Islam (FOI) is an all male militarytype group within the Nation of Islam (NOI). The NOI is a
Chicago, Illinois, headquartered nationwide black organization
seeking a separate black nation, and considering all whites
to be "devils." FOI members receive instructions in judo
and karate and have the mission of protecting NOI officials,
and karate and have the mission of protecting NOI officials,
property, women, and themselves, if attacked, at all costs.
FOI members serve as body guards for NOI leaders and
